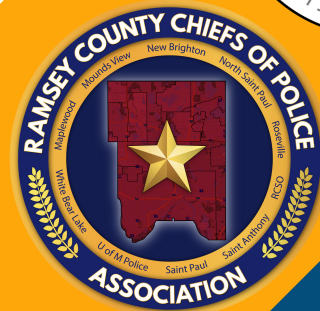
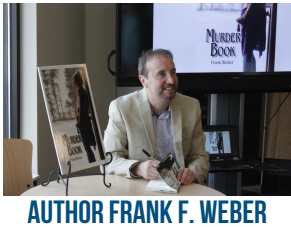
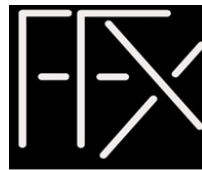

RHONDA SCHARF

AMBER PETERSON

Amber's experience in Public Safety started with her career as a police officer at Duluth PD. While there, she personally struggled through a number of critical incidents and watched as her peers went through the same. Amber observed the connection between her own negative mindset during these challenging times with her inability to best serve her community, deeply connect with her peers and family, and practice the self-care she needed. She knew she was NOT the only one fighting to find this balance...



Having realized this link, Amber left Public Safety to fulfill her true mission: to support her sworn and civilian peers in choosing to be their healthiest, most fulfilled selves **DESPITE** the job. She has worked with and coached Public Safety and city employees to define their core values, develop goals, and strategize how to find fulfillment in life (in AND out of work!)



MEET THE SPEAKER

CHIEF ERIK FADDEN

Erik Fadden grew up in the Plymouth area and has devoted nearly all of his professional life to serving the community as a member of the Plymouth Police Department.

Beginning with Minnetrista PD in 2001 as a police officer, he was hired by Plymouth PP in 2004 where he served as a Patrol Officer, then Canine Handler. In 2009 he was promoted to Sergeant where he served as a patrol supervisor until 2015, when he was appointed to the position of Proactive Police Sergeant. He supervised the special investigations unit, tasked with combatting quality of life issues including narcotics and human trafficking.



In 2018 Fadden was named Deputy Police Chief. In February 2021, he was appointed Director of Public Safety where he oversees the Police Department and Fire Department. He is also currently on the board of the Hennepin County Chiefs of Police Association.

Fadden holds a bachelor's degree in law enforcement from UMN, Mankato and has pursued professional studies at Northwestern University in Evanston, IL. and the Police Executive Research Forum in Washington, D.C.



MEET THE SPEAKER

CAPTAIN MICHAEL REED

Captain Reed began his career with the Rice County Sheriff's Department in 1999 as a deputy. In 2001, he was hired by Plymouth PD as a patrol officer. Reed was a member of the Plymouth S.W.A.T team for 10 years, becoming the assistant team leader and ultimately the S.W.A.T Commander. Reed was also a member of the Hennepin County Weapons of Mass Destruction team and served as a team leader.

In 2007, he was promoted to police sergeant where he served as a patrol supervisor until 2011. Reed was appointed the position of proactive police sergeant and supervised the special investigations unit, tasked with combating quality of life issues including narcotics and human trafficking.

In 2015, Reed was promoted to Captain. He has served as the Commander for the Special Operation, Patrol Division and Services Divisions. He is currently the Services Division Commander and oversees the investigations division.

Reed holds a bachelor's degree in psychology, criminal justice and social anthropology from Gustavus Adolphus College, St. Peter MN. Reed has pursued professional studies at the University of St. Thomas and the Police Executive Research Forum in Washington, D.C.

MIKE S. GOLDSTEIN

Mike is the Vice President of Security for Pohlad Companies and Co-Founder of Provicta, LLC.

Previously, Mike achieved a 31-year law enforcement career with the City of Plymouth, Minnesota where he spent 17 years as the department's Chief of Police and Emergency Management Director. Prior to his retirement from the public sector, Mike spent five years as the City's Public Safety Director having oversight of both the police and fire departments.

In the midst of his law enforcement career, Mike co-founded Provicta to provide a community of support for the physical and mental wellbeing of first responders.

Mike is on the Board of Directors for both the Minnesota Chiefs of Police Foundation and the Twin Cities Security Partnership. Mike is a past President for the Minnesota Chiefs of Police Association, is a past President for the Hennepin County Police Chiefs Association and participated in several other law enforcement-related organizations including: the State of Minnesota's Violent Crime and Coordinating Council (founding member and past Chair); the Twin Cities Security Partnership Board of Directors (law enforcement representative); the IACP's State Association of Chiefs of Police (past state representative); and the Federal Bureau of Investigation's Joint Terrorism Task Force Executive Board.

Mike is also on the Board of Directors for two non-profits: Public Safety Ministries Incorporated and the Northern Star Scouting Council.

Mike possesses a Master of Arts Degree in Public Safety Education and Administration and a Bachelor of Arts Degree in Criminal Justice both from the University of St. Thomas.

Mike is a former adjunct faculty member at the University of St. Thomas and is a speaker on leadership practices and wellness initiatives for public safety personnel. As such, Mike's presentations provide audience members an opportunity to explore innovative practices to benefit their organizations and more importantly, their personnel. Mike has presented across Minnesota and nationally for the International Association of Chiefs of Police, the National League of Cities, the Minnesota Chiefs of Police Association, the League of Minnesota Cities Insurance Trust and Blue H.E.L.P.
