History

MN - Law Enforcement Administrative Professionals (MN-LEAP) started in Minnesota in 1999 after a representative from the National FBI Training Unit, Debbie Beebe, came to the Twin Cities to conduct training for law enforcement assistants. A need was identified for specialized training for this group, as well as networking opportunities to share knowledge.

Attendees from several agencies worked together to form MN-LEAP (Formerly PLEAA), a non-profit agency that works to provide relevant training and networking opportunities for this group.

Members include representatives of any city, county, state or federal law enforcement agency support staff; including many administrative positions; bookkeepers; admin CSO; admin office supervisors, specialists, assistants, managers; background investigators and supervisors; civil process positions; confidential office positions; crime analyst; crime prevention; crime scene & evidence; data release and specialists; evidence; executive administrative positions; investigative positions; jail administrative and technical positions; records clerks, technicians, managers, supervisors, specialists, administrator, support specialist; legal administrative and support positions; paralegal; office support and management; property and evidence room; sheriff's administrative assistants; secretary; receptionist; supervisors; support services; victim/witness liaison-legal assistant; warrants specialist and any other non-sworn agency support.

Training

Twice a year in spring and fall, MN-LEAP sponsors training opportunities at a low cost for this group. Training subjects include data practices, customer service, generation communication, diversity, critical incident debriefing for records staff, and a variety of law enforcement related topics. Attendees will receive information and knowledge to share with their agencies. Members also network with others. It is advantageous to have a group of peers to call on when questions arise about how a program is configured or run.
